

CDSA Club Policies for 2018 Membership Year

To be reviewed yearly at the October Board of Directors' meeting.

- 1.) Membership dues shall be \$75.00 per year.
 - a.) Junior member (under 18) dues shall be \$10.00 per year (60 as of 9-2017).
 - b.) Senior member (65 years of age or older) dues shall be \$25.00 per year (298 as of 9-2017).
Those seniors who were members before the dues increase pay \$10.00 (12 seniors as of 9-2017).
 - c.) Every member shall receive a current copy of the CDSA Range Rules upon renewal. Send a self addressed, stamped business size envelope to CDSA at 106 Coketown Road, Coraopolis, PA 15108.
- 2.) Initiation fee shall be \$125.00. Junior members will pay initiation fee when their membership is converted to a full membership. See Bylaws.
 - a.) Law Enforcement Departments shall pay no initiation fee.
 - b.) In lieu of the full initiation fee, a membership that lapses can be reinstated for a fee of \$25.00 per year dues were not paid, in addition to current year dues payment (\$100.00 total in 2018). If there are no openings the member must go to the bottom of the waiting list.
- 3.) All new members must attend the CDSA Safety Orientation Course before they will be given range access.
- 4.) Junior members who are over 18 and grandfathered in must be observed by a card carrying adult member. They may not shoot at the same time, even when they are over 18. The junior member will not be issued a fob until converting their membership to an adult.
- 5.) Range rules will be reviewed and edited at the October BOD meeting. Changes will take effect on November 1, so copies may be distributed to members as they renew. Changes will also be posted on all ranges.
- 6.) Alcohol is not allowed on CDSA property unless approved by the Officers of CDSA. Any time alcohol is consumed on CDSA property all ranges must be closed.
- 7.) All adjacent ranges must be closed before entering the Bullet Impact Zone,. All firearms must be cased. All three bays must be closed on the Short Range Bays. This applies to the area inside the gate between the outside range berm and the fence. Bullet Impact Zones are clearly posted and cabled.

Rules Policies

1.) No one is in a position to change or relax any rule, except the Officers of CDSA. If you want to suggest changes please come to a membership meeting the third Tuesday of every month at 7:30pm.

2.) Some members who have been with the club a long time feel a sense of entitlement. They don't like the rules and do not think the rules apply to them. Rules must be obeyed and enforced equally and fairly by all members. The RSO's must be supported by the Officers of CDSA.

3.) Some of our members are confusing rapid fire with haphazard fire. Rapid fire can, and should be aimed fire. The deciding factor would be how the muzzle is moving and where the bullets are going.

4.) No drawing and firing from a holster anywhere except in the Draw and Shoot Bay on the Short Range Bays. Follow the rules carefully. Not even with an unloaded gun. We recommend you dry fire practice at home with an unloaded gun.

Law enforcement agencies who rent our range under contract may move off the concrete onto the grass in front of the firing line to draw and fire from the holster. They will provide their Range Master and CDSA will provide an RSO to oversee use of the range.

5.) Each member entering any CDSA range must swipe their fob. Members are not permitted to allow other members to enter without swiping their own fob.

6.) A jammed gun with a live round or fired case in the chamber may not leave bench area until it is cleared. A muzzleloader may not leave bench area with a bullet in the bore.

7.) Jr. Rifle and Jr. Archery participants may not enter the indoor range while a member's firearms are there. Wait in the Ready Room until the member leaves with their firearms.

8.) Some members think our safety program is not necessary and we have too many rules. The majority feel safer and more comfortable on our ranges. As our members become familiar with the rules and RSOs, the problems will diminish.

9.) Members who use double gun cases should put a gun sock on the gun whose muzzle will be pointing the wrong way when the case is opened. This applies to multi gun handgun cases as well.

10.) The vision barriers have been made permanent. Their purpose is to stop bullets from going over the backstop. Members will have to adapt their equipment to function with them.

11.) The key in the RSO clip board in the RSO cabinet in the ready room opens all the locks on the outdoor ranges. Gates are to be opened to allow vehicle access in the event of an emergency situation. Follow CDSA Emergency Action Plan, posted on all ranges
